**RCA LABS: Faked lawyer's letter on website www.fraudebiocell.com /
forgery of documents and defamation by RCA LABS**

Dear Sirs,

We refer to your information about the website www.fraudebiocell.com of an unknown third party which posts a letter with the title "FALSIFICACION DE DOCUMENTOS Y USO DE IDENTIDAD INDEBIDA". After studying the facts of the case at hand we can comment this website and the respective letter as follows:

- The letter with the title "FALSIFICACION DE DOCUMENTOS Y USO DE IDENTIDAD INDEBIDA" is a **fake – and the authors behind this letter commit a criminal act, in particular forgery of documents as well as libel (defamation)**.
- The letter published on the website www.fraudebiocell.com has not been written by myself, Dr. Christian Rohner, attorney at law (Esq.), Zurich/Switzerland (hereafter "the Undersigned"), as this is falsely indicated in this faked letter. Accordingly, the signature in this faked letter is a forgery, it has been taken illegally from original letters which have been posted online earlier (cf. our additional letter of today entitled "Original letters of Dr. Christian Rohner").
- The Undersigned, Dr. Christian Rohner, is one of the two founding partners of the Swiss law firm KIKINIS ROHNER SCHWENNINGER WEINMANN which is falsely indicated in the letterhead of this faked letter; the law firm was later renamed as KRSW WEINMANN. The Undersigned can confirm that no lawyer of KIKINIS ROHNER SCHWENNINGER WEINMANN respectively KRSW WEINMANN has been writing this faked letter or has been authorized to do so. Accordingly, the use of the letterhead of KIKINIS ROHNER SCHWENNINGER WEINMANN is a forgery too.



- The Undersigned is not surprised that in this faked letter even his name has been misspelled by the delinquents, namely “Ronher” instead of “Rohner”.
- The domain name of the website fraudebiocell.com on which the faked letter is published has been created on 20 May 2010; at this date the Undersigned had already left the former law firm KIKINIS ROHNER SCHWENNINGER WEINMANN respectively KRSW WEINMANN and has been practicing with the new law firm SWISSBERG.
- The Undersigned is not aware of any pending legal actions against our clients in Switzerland; in particular, the Undersigned is not aware of any pending legal action at “WIPO” (French “OMPI”) as it is falsely indicated in the faked letter.
- The Undersigned is not familiar with a company called “RCA LABS” or the “Departemento Legal” of such a company which is the company mentioned on the bottom of the faked letter. The authors behind this faked letter are deliberately falsifying a lawyer’s letter and defaming our clients.

Based on the above we immediately start with the following legal steps:

- (1) Starting criminal actions in Mexico against the authors behind this faked letter, allegedly people behind the company called “RCA LABS”.**
- (2) Locating the web server the of the website www.fraudebiocell.com and filing a request for immediate stop of the website due to its illegal content.**
- (3) Informing the designer of the website www.fraudebiocell.com about the faked letter resp. the illegal content of the website.**

For the sake of good order we also make a note of the following:

- Dr. Marc Schwenninger, attorney at law (Esq.), and the Undersigned, Dr. Christian Rohner, attorney at law (Esq.), respectively the Swiss law firm KIKINIS ROHNER SCHWENNINGER WEINMANN / KRSW WEINMANN have been representing Biocell Ultravital 24 kt GmbH, a Swiss private limited company, as well as the members of this company, since the beginning.
- Since May 2010, with the launch of the Swiss law firm SWISSBERG the Undersigned, Dr. Christian Rohner, is representing Biocell Ultravital 24 kt GmbH as well as the members of this company in the name of the new law firm SWISSBERG. However, the earlier original letters of the Undersigned written under the old law firm KIKINIS ROHNER SCHWENNINGER WEINMANN respectively KRSW WEINMANN remain valid (cf. our additional letter of today entitled “Original letters of Dr. Christian Rohner”).
- The law firm SWISSBERG and the Undersigned are protecting the legal interests of Biocell Ultravital 24 kt GmbH in Switzerland as well as abroad, in particular with regard to trademark conflicts and counterfeits.



We hope that the responsible department will take the faked letter from the internet soon, and that the criminal authorities in Mexico will find and penalize the delinquents.
